Keywords (5-7 words or phrases) should not be duplicated in the title of the article or contain common words. Keywords should be given in the nominative case, separated by semicolons.

The titles and years of sources in the text should clearly correspond to the data in References. References in the text should be given in APA (American Psychological Association (APA) Style), 7th edition.

Conclusions should reflect the research results; correspond to the aim and title of the article. The conclusions should be logically related to the content of the article; do not contain information not provided in the text of the manuscript. It is important to note the scientific novelty of the results, their value and/or significance for the development of science. Finally, it is necessary to formulate prospects for further research in this area.

This section is intended to express gratitude to individuals and/or organisations for ideas or assistance that contributed to the research. If you do not have any acknowledgements, please indicate "None".

# Conflict of interest (Times New Roman, 14-point font size, bold, left alignment)

Conflict of interest text (Times New Roman, 14-point font size, width alignment)

Authors are required to disclose any potential sources of conflict of interest. The presence of a conflict of interest is not an obstacle to publication. In the absence of a conflict of interest, it should be stated: "The author declares that there is no conflict of interest".

### References (Times New Roman, 14-point font size, bold, left alignment)

Technical requirements for the List of References: Times New Roman, 12-point font size, width alignment, paragraph indentation (1.25), single line spacing, 0 pt interval between paragraphs before and after.

The list of references should include at least 15 relevant scientific studies from the last 5 years. Sources in the References should be listed in alphabetical order. It should be formatted according to the APA (American Psychological Association (APA) Style), 7th edition. If you have a digital object identifier (DOI), you must add it to the description of the source. At the end of the entry, the original language should be indicated: [in Ukrainian], [in English]. We recommend avoiding the use of Russian sources.




Figure 1. Figure title (Times New Roman, 10-point font size, centre alignment)

**Graphic materials.** Illustrations (schemes, diagrams, photographs) are placed immediately after the paragraph in which they are mentioned for the first time and are accompanied by references (Figure 1). The title is placed below the illustration, and the sources are placed below the title. File format of illustrations: jpg. Resolution: 300 dpi. The author is responsible for obtaining permission to reproduce the illustrations.
